DIRECTIONS FOR USE:

Note: To control microbiological growth in water cooling towers, clean system to remove biological growth and other deposits. Slug dose MICROCIDE LA-40 at a point in the system where it will be uniformly mixed.

Initial Dose: Add 280 to 700 mL. of MICROCIDE LA-40 to 10,000 litres of water in the system. Repeat until control is achieved.

Subsequent Dose: When microbial control is evident, add 80 to 700 mL. of MICROCIDE LA-40 per 10,000 litres of water in the system every 7 days or as needed to maintain control. The frequency of addition will depend upon the relative amount of bleedoff and the severity of the microbiological problem.

DO NOT discharge effluent containing this product into sewer systems, lakes, streams, ponds, estuaries, oceans, and other waters.

DO NOT contaminate irrigation or drinking water supplies or aquatic habitats by cleaning of equipment or disposal of wastes.

PRECAUTIONS:

FIRST AID:

If in eyes: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

If on skin or clothing: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice.

If inhaled: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

If swallowed: Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.
