Place thumb in front of orange safety clip and remove it by lifting up and back. Point nozzle directly toward bear's eyes and nose. Depress actuator tab for a burst of spray to a maximum range of 4 meters. Move away to avoid exposure to spray. Replace orange safety clip after use.

TIMING OF APPLICATION: Capsaicin sprays have been proven effective in repelling bears approaching closely. Use only as a last resort. There is no guaranteed method of responding to a bear encounter, each case is unique.

USE LIMITATIONS: This product is not to be sold to anyone under 18 years of age.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Contents under pressure. Container may explode if heated. Do not place in hot water or near radiators, stoves or other sources of heat.
