**DIRECTIONS FOR USE:**

To be used only in the manufacture of a pesticide which is registered under the PEST CONTROL PRODUCTS ACT.

**PRECAUTIONS:**

KEEP PRODUCT OUT OF REACH OF UNAUTHORIZED PERSONNEL.

Avoid all contact by mouth, with skin or eyes. May cause eye or skin irritation. May cause skin sensitization reactions in certain individuals. Wear coveralls over normal work clothes, chemical resistant gloves and face shield when handling the concentrate (i.e. mixing and loading). Accidental splashes on exposed skin or eyes should be washed off immediately with plenty of water. Wash hands, face and exposed skin before eating, drinking or smoking and after leaving the work area. Wash all protective clothing thoroughly after use.

**FIRST AID:**

Call a poison control centre or doctor for treatment advice. IF ON SKIN OR CLOTHING: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice. IF SWALLOWED: Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person. IF INHALED: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

**STORAGE:**
