**DIRECTIONS FOR USE:** Apply sparingly on exposed skin, not under clothing and only when necessary. Reapply after 6 hours if necessary. **TO APPLY TO FACE:** Spray hands and apply avoiding eyes and mouth. Do not spray in enclosed spaces.

**PRECAUTIONS:** KEEP OUT OF REACH OF CHILDREN. Avoid contact with eyes and mouth. Do not use on children under 12 years of age. May cause skin irritation. Discontinue use if signs of irritation appear. Avoid contact with synthetic fabrics. May damage furniture finishes, plastics and painted surfaces. Flammable. Keep away from open flames or spark. Do not store at temperatures above 50C.

**FIRST AID:** If irritation or other adverse effects develop wash with soap and water immediately. Seek medical attention if symptoms persist. If in eyes: Hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. If inhaled: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice. If ingested, call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

**TOXICOLOGICAL INFORMATION:** Treat symptomatically.

**DISPOSAL:** Do not reuse empty container; wrap and discard in household garbage.
