DIRECTIONS FOR USE:

To be used only in the manufacture of a herbicide which is registered under the **PEST CONTROL PRODUCTS ACT**.

LIMITATIONS:

Do not apply directly as is to crops; for formulation only.

PRECAUTIONS:

1. **PREVENT ACCESS BY UNAUTHORIZED PERSONNEL.**

STORAGE:

FIRST AID INSTRUCTIONS:

IF IN EYES: Hold eye open and rinse slowly and gently with water for 15 - 20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.
