DIRECTIONS FOR USE:

Decco 276 EC Potato Sprout Inhibitor is applied at a 1% active ingredient level on washed and damp dried potatoes. The diluted material should be applied using spray nozzles placed evenly across the rolls on which the potatoes are being moved. The diluted solution can also be applied by a foaming system in conjunction with a suitable foaming agent.

DILUTION OF THE CONCENTRATION: Add 1 litre of Decco 276 EC Potato Sprout Inhibitor to 24 litres of water and mix well. A milky white emulsion will develop. Use this diluted emulsion at a rate of 1 litre per tonne of potatoes (1 litres of Decco 276 EC Potato Sprout Inhibitor per 25 tonnes of potatoes). Do not reuse diluted material that was prepared 24 or more hours earlier without mixing well.

NOTICE: Decco 276 EC Potato Sprout Inhibitor is used for treatment of potatoes after harvest. Potatoes must be cured prior to treatment. For maximum sprout inhibition, the potatoes should be washed clean before application of CIPC. Once opened, use the entire contents of the container within 60 days. Do not use on seed potatoes.

FIRST AID:

Personal Protective Equipment:

For mixing and loading, wear cotton coveralls and chemical-resistant gloves. For application using the screened sprayer system and for bagging / packing potatoes, wear cotton coveralls and chemical-resistant gloves.

Engineering Control:

Installation of a shield around the conveyor belt is required to prevent spray mist from drifting.

DISPOSAL:

- 1. Triple or pressure rinse the empty container. Add the rinsing to the spray mixture in the tank.
- 2. Follow provincial instructions for any required additional cleaning of the container prior to its disposal.
- 3. Make the empty container unsuitable for further use.
- 4. Dispose of the container in accordance with provincial requirements.
