DIRECTIONS FOR USE

AQUANET® is a concentrated water soluble impregnation agent for cages and ropes in the aquaculture farming industry.

1. The surface should be cleaned and dry before application.
2. Dilute each container with 30% fresh water and mix carefully.
3. Stir contents of container before each use.
4. Apply liberally by dipping.
5. After dipping, allow article to remain in solution a minimum of 10 minutes.
6. Allow 5-6 hours drying time between coats.
7. Allow minimum 24 hours air drying before use.
8. Clean tools with water when finished.

Do not apply at or below freezing temperatures.

DO NOT apply this product in a way that will contact workers or bystanders, either directly or through drift. Only protected handlers may be in the area during application.

DO NOT contaminate irrigation or drinking water supplies or aquatic habitats by cleaning of equipment or disposal of wastes.

DO NOT apply this product directly to freshwater habitats (such as lakes, rivers, sloughs, ponds, prairie potholes, creeks, marshes, streams, reservoirs and wetlands), or estuarine/marine habitats.

PRECAUTIONS

KEEP OUT OF REACH OF CHILDREN. DO NOT get in eyes, or skin, or on clothing. DO NOT take internally. Handle with care and mix only in a closed container. Use only in well ventilated areas. When using, do not eat, drink or smoke.

Use an air fed respirator with a full face mask during handling and applying. Wear chemical resistant gloves and footwear, and chemical resistant clothing with head covering at all times during handling and applying.

Remove personal protective equipment immediately after handling this product. Wash the outside of gloves before removing. As soon as possible, wash thoroughly and change into clean clothing.

Remove clothing/personal protective equipment immediately if pesticide gets inside. Then wash thoroughly and put on clean clothing. Discard clothing and other absorbent material that have been drenched or heavily contaminated with the product's concentrate. Do not reuse them.

For cleaning/maintaining personal protective equipment, use detergent and hot water. Keep and wash personal protective equipment separately from other laundry.

Wash hands before eating, drinking, chewing gum, using tobacco or using the toilet.

ENVIRONMENTAL HAZARDS

Toxic to aquatic organisms. Do not contaminate water. Do not apply directly to water by cleaning of equipment or disposal of wastes. Do not allow chips or dust generated when cleaning the nets to enter water.

PHYSICAL OR CHEMICAL HAZARDS: Not combustible (water-based)

FIRST AID

STORAGE: Keep from freezing.

DISPOSAL:

1. Triple- or pressure-rinse the empty container. Add the rinsing to the dipping container.
2. Follow provincial instruction for any required additional cleaning of the container prior to its disposal.
3. Make the empty container unsuitable for further use.
4. Dispose of the container in accordance with provincial requirements.
