Hartz Reference 100 is most effective when used as part of a total program aimed at reducing fleas and ticks in the dog's environment. Be sure to treat the animal's bedding and surroundings with products registered for these uses, such as the Hartz Control Pet Care System line.

DIRECTIONS FOR USE:

DO NOT USE ON CATS OR OTHER ANIMALS. This product is packaged in single dosage tubes. This package contains three monthly $2\ mL\ [1\ mL]$ dosages.

Do not use this product more often than once every 3 weeks. Treat your dog or puppy monthly for continual pest control in situations where there is an ongoing risk of pest infestation. Do NOT administer by mouth. Consult a veterinarian before using on sick, aged, pregnant or nursing animals or animals receiving drug or other pesticide treatment. Do not use on animals under 12 weeks of age. Discontinue use if adverse effects are observed. If condition persists, consult your veterinarian. RETAIN PACKAGING INFORMATION FOR FUTURE REFERENCE.

For effective flea and tick control, treatment of the pet should be combined with the sanitation of any area used by the pet. Vacuum floors, carpets, furniture, etc. (discard vacuum bag after use) and wash the pet's bedding, living quarters, and surrounding areas. If pest problems persists, an insecticidal premise treatment (e.g. Hartz Control Pet Care System Home Flea & Tick Killer) may be required. A veterinarian should be consulted when pest infestation continues to be a problem on the pet.

{Note to PMRA - Different types of tubes are available which differ only in the method employed to open the individual tubes. Hence, "alternate" directions (Instruction 2) are available.}

FOR LARGE DOGS (14 Kg and Over):

- 1. Remove one applicator tube from package and hold in an upright position.
- 2. Simply press cap down to break the seal of tube.
- [2. Pull cap off. Turn the cap around and place on top of tube. Press cap down to break the seal of tube.]
- [2. Hold the tube in one hand and, with the other hand, snap off cap.]
- [2. Hold the tube in one hand and, with the other hand, remove cap and snap off tip carefully.]
- 3. Remove cap carefully. Position the tip of the tube on the dog's back between the shoulder blades and squeeze out half the contents of the tube.
- 4. Invert the applicator tube upright and go to the dog's tail. Position the tip of the tube on the dog's back at the base of the tail and apply the remaining contents of the tube.

FOR SMALL DOGS (Less than 14 kg)

- 1. Remove one applicator tube from package and hold in an upright position.
- 2. Simply press cap down to break the seal of tube.
- [2. Pull cap off. Turn the cap around and place on top of tube. Press cap down to break the seal of tube.]
- [2. Hold the tube in one hand and, with the other hand, snap off cap.]
- [2. Hold the tube in one hand and, with the other hand, remove cap and snap off tip carefully.]
- 3. Remove cap carefully. Position the tip of the tube on the dog's back between the shoulder blades and squeeze out the contents of the tube.

PRECAUTIONS:

<u>HUMANS:</u> KEEP OUT OF REACH OF CHILDREN. Avoid contact with mouth, eyes and clothing. Use rubber gloves when applying product. Avoid contact with pet until dry. After handling or applying, wash hands (or any other skin that came into contact with the product) with soap and water. Avoid product contact with food, food utensils or places where food is prepared or stored.

<u>PETS:</u> **DO NOT USE ON CATS.** Toxic to cats. Cats that actively groom or engage in close physical contact with treated dogs may be at risk of serious harm, including death. FIRST AID:
