**INSECT CONTROLLER**

A physical control to which insects CANNOT build up a resistance.

**FOR:** Earwigs, cockroaches, beetles, spiders, wasps, ants, fleas, silverfish, bedbugs, crickets, grain insects. This product is odour-free, does not discolour and is not harmful to animals, fish, fowl or food, if label directions are followed.

**DIRECTIONS FOR USE:** For use with or without attractants, indoor and outdoor. Remove cap and cut tip of spout to 1 cm (1/4") in diameter. Apply INSECT STOP Cockroach and Ant killer to cracks and crevices, under and behind appliances, cupboards, and other places where insects are found. Use squeeze bottle to apply into cracks and crevices. When treating surfaces, apply as a thin film at the rate of 500 grams per 100 sq. meters.

NOTE: Whenever applied, the powder controls until it is washed away.

**APPLICATION WITHOUT ATTRACTANTS:** When crawling over the powder or when contacted directly with the powder, the insect cannot brush it off. The powder cuts through the insect's waxy outer layer which leads to a loss of bodily fluids and death. Seemingly unaffected, the insect may take up to two days to die.

**APPLICATION WITH ATTRACTANTS:**

When the powder is mixed and applied with attractants, the insect is attracted by the baited powder and tends to ingest it. When it does swallow it, its digestive system is affected. If used with bait, mix with attractants suggested, place baited INSECT STOP Cockroach and Ant killer into cracks and crevices, or in discrete small piles under and behind appliances, furniture, cupboards and also cover surfaces using a thin film of INSECT STOP Cockroach and Ant killer. Check baits periodically and vacuum or remove if mouldy or otherwise spoiled.

**SUGGESTED ATTRACTANTS:** (Mix from 25% to 50% in volume) Icing sugar, and/or cereal powder, and/or peanut or other nut powders, and/or powdered dried fruits, and/or powdered yeast, and/or powdered soup mixes, and/or dried egg powder, and/or any other dried powder substance that attracts the insect.

**PRECAUTIONS:** KEEP OUT OF REACH OF CHILDREN. Avoid: breathing dust - contact with eyes. Wash hands after use.

**FIRST AID:** In case of contact with skin, flush with plenty of water. Contact a physician if irritation persists. In case of contact with eyes, hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. If inhaled, move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

**TOXICOLOGICAL INFORMATION:**

Treat symptomatically.

**DISPOSAL:** Do not reuse container - When empty wrap and dispose of with regular household garbage.
