## **DIRECTIONS FOR USE**

To be used only for the manufacturing of industrial pesticides which are registered under the Pest Control Products Act. Formulators of end use pesticide products are required to obtain their own registration for their product.

### **PRECAUTIONS**

#### **DANGER KEEP OUT OF REACH OF CHILDREN AND UNAUTHORIZED PERSONNEL**

Harmful or fatal if swallowed, inhaled, or absorbed through the skin. Corrosive to eyes and skin. Do not get in eyes, on skin, or on clothing. Do not inhale. Wear chemical-resistant gloves, and full-face protection (eg. Faceshield) when handling. Wear a cartridge respirator if the area is not well ventilated and during clean-up, maintenance and repair activities. Wash hands and face before eating, drinking, smoking, and using the toilet. **Keep away from open flame.** Keep the container closed when not in use.

### **FIRST AID**

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

**Eye exposure:** Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

**Contact with skin or clothing:** Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice.

**Inhalation:** Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

**Ingestion:** Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

**TOXICOLOGICAL INFORMATION:** Note to physician: Probable mucosal damage following ingestion may contraindicate gastric lavage. Avoid giving alcohol or alcohol related products.
