1.0 NOTICE TO USER

This pest control product is to be used only in accordance with the directions on the label. It is an offence under the *Pest Control Products Act* to use this product in a way that is inconsistent with the directions on the label.

2.0 FIRST AID

IF POISONING IS SUSPECTED, IMMEDIATELY contact a physician or a poison control centre. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

If swallowed, call a poison control centre or doctor **IMMEDIATELY** for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

If on skin or clothing, take off contaminated clothing. Rinse skin **IMMEDIATELY** with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice.

If inhaled, move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

If in eyes, hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

3.0 TOXICOLOGICAL INFORMATION

NOTE TO PHYSICIAN: Treat symptomatically. Induce emesis or lavage stomach if a large amount of product has been ingested.

4.0 PRECAUTIONS

PREVENT ACCESS BY UNAUTHORIZED PERSONNEL. Harmful if swallowed. May irritate eyes. Avoid contact with eyes or prolonged contact with skin. Wash hands and face after handling and before eating or smoking. Wear long-sleeved coveralls over normal work clothing and chemical resistant gloves when handling product.

5.0 ENVIRONMENTAL PRECAUTIONS

TOXIC to aquatic organisms.

Do not contaminate food, feed, domestic or irrigation water supplies, lakes, streams and ponds.

DO NOT discharge effluent containing this product into sewer systems, lakes, streams, ponds,
