## **DIRECTIONS FOR USE**

To be used only in the manufacture of a pesticide which is registered under the *Pest Control Products Act*.

## **PRECAUTIONS**

Strictly observe all precautions for handling and using pesticides. Avoid contact with skin, eyes, clothing and inhalation of spray mist. Do not contaminate food, feed or water supplies.

PREVENT ACCESS BY UNAUTHORIZED PERSONNEL.

## **FIRST AID**

**If on skin or clothing:** Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice.

**If in eyes:** Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

**If swallowed:** Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

**If inhaled:** Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

## **TOXICOLOGICAL INFORMATION**

There is no specific antidote. This product is of very low acute toxicity by the oral and dermal routes and poisoning is unlikely to occur. Treatment should be symptomatic.
