HAZARDS TO HUMANS

FIRST AID

STORAGE AND HANDLING

To prevent contamination store this product away from food or feed.

AQUCAR GA 30 LT Water Treatment Microbiocide solutions are incompatible with many commonly used materials of construction such as steel, galvanized iron, aluminum, tin, and zinc. These solutions can be stored and handled in baked phenolic-lined steel, polyethylene, stainless steel, or reinforced epoxy-plastic equipment. This product freezes at about - 43° C. Therefore, unless the storage tank is inside or underground, heating and insulation may be required. If heating is needed, exposure to high temperatures should be avoided. For short storage times (up to about 1 month), temperatures of up to 38° C can be tolerated but the preferred maximum storage temperature is about 27° C.

A stainless steel centrifugal pump is suggested for transfer service. Spiral wound stainless steel with TEFLON® is suitable for gaskets and packing.

DISPOSAL:

1. Triple or pressure-rinse the empty container. Add the rinsings to the treatment site.
2. Follow provincial instruction for any required additional cleaning of the container prior to its disposal.
3. Make the empty container unsuitable for further use.
4. Dispose of the container in accordance with provincial requirements.

DIRECTIONS FOR USE

DO NOT open pour more than 20 L of concentrate per day. Use an automatic addition system if using more than 20 L of concentrate per day.

DO NOT contaminate irrigation or drinking water suppliers or aquatic habitats by cleaning of equipment or disposal of wastes.

DO NOT discharge effluent containing this product into sewer systems, lakes, streams, ponds, estuaries, oceans or other waters.

WATER FLOODS

AQUCAR GA 30 LT Water Treatment Microbiocide should be added to a water flood system at a point of uniform mixing.

Initial Treatment: When the system is noticeably contaminated, add 167 to 8333 ppm AQUCAR GA 30 LT Water Treatment Microbiocide (0.2 to 8.3 Liters AQUCAR GA 30 LT Water Treatment Microbiocide per 1000 Liters flood water). Repeat until control is achieved.

Subsequent dose: When microbial control is evident, add 33 to 8333 ppm AQUCAR GA 30 LT Water Treatment Microbiocide (0.03 to 8.3 Liters AQUCAR GA 30 LT Water Treatment Microbiocide per 1000 liters flood water) to the system weekly, or as needed to maintain control.

DRILLING, COMPLETION, AND WORKOVER FLUIDS

AQUCAR GA 30 LT Water Treatment Microbiocide should be added to a drilling fluid system at a point of uniform mixing such as the circulating mud tank.

Initial Treatment: Add 90 to 1665 ppm AQUCAR GA 30 LT Water Treatment Microbiocide (1.2 to 25 liters AQUCAR GA 30 LT Water Treatment Microbiocide per 100 barrels of fluid) to a freshly prepared fluid, depending on the severity of contamination.

Maintenance Dosage: Maintain a concentration of 90 to 1665 ppm AQUCAR GA 30 LT Water Treatment Microbiocide by adding 1.2 to 25 liters of AQUCAR GA 30 LT Water Treatment Microbiocide per 100 barrels of additional fluid, or as needed, depending on the severity of contamination.

PACKER FLUIDS

AQUCAR GA 30 LT Water Treatment Microbiocide should be added to a packer fluid at a point of uniform mixing such as a circulating holding tank. Add 90 to 1005 ppm AQUCAR GA 30 LT Water Treatment Microbiocide (1.2 to 16 liters AQUCAR GA 30 LT Water Treatment

Microbiocide per 100 barrels of fluid) to a freshly prepared fluid, depending on the severity of contamination. Seal the treated packer fluid in the wall between the casing and production tube.

GAS PRODUCTION AND TRANSMISSION PIPELINES AND SYSTEMS

AQUCAR GA 30 LT Water Treatment Microbiocide should be added to a gas production or transmission line via direct injection. The application should be conducted to ensure maximum distribution of AQUCAR GA 30 LT Water Treatment Microbiocide through the entire internal surface of the pipeline by adding an amount of biocide which eventually comes out the other end of the pipeline. Criteria for success of the treatment will be reduction in bacterial count and/or corrosion rates. To facilitate application it may be desirable to dilute AQUCAR GA 30 LT Water Treatment Microbiocide with the appropriate solvent immediately before use. The concentration in the solvent should not fall below the 840 to 8340 range. Injections to the system should be made on a weekly basis, or as needed to maintain control.

GAS STORAGE WELLS AND SYSTEMS

Individual injection wells should be treated with a sufficient quantity of AQUCAR GA 30 LT Water Treatment Microbiocide to produce a concentration of 840 to 8340 ppm AQUCAR GA 30 LT Water Treatment Microbiocide when diluted by the water present in the formation. Injection should take place before gas is injected (during the summer). Injections should be repeated yearly, or as needed to maintain control.

Individual drips should be treated with a sufficient quantity of AQUCAR GA 30 LT Water Treatment Microbiocide to produce a concentration of 330 to 3330 ppm AQUCAR GA 30 LT Water Treatment Microbiocide when diluted by the water present in the drip. Injections should be repeated yearly, or as needed to maintain control.

HYDROTESTING

Water used to hydrotest pipelines or vessels should contain 165 to 6660 ppm AQUCAR GA 30 LT Water Treatment Microbiocide (0.15 to 6.6 liters AQUCAR GA 30 LT Water Treatment Microbiocide per 1000 liters water), depending on water quality and length of time the equipment will remain idle.

PIPELINE PIGGING AND SCRAPING OPERATIONS

Add AQUCAR GA 30 LT Water Treatment Microbiocide to a slug of water immediately following the scraper (ideally this water volume can be kept to a minimum and contained between the scraper and a trailing pig). Sufficient AQUCAR GA 30 LT Water Treatment Microbiocide should be added to produce a concentration of 0.15 to 1.7% (0.15 to 1.7 liters AQUCAR GA 30 LT Water Treatment Microbiocide per 100 liters water), depending on the length of the pipeline and the severity of biofouling.
