This insecticide is for use only in the automatic Mister dispenser, which releases 27.5 mg of insecticide every 7-1/2 minutes. The continuous use of this insecticide will reduce flying insect populations (flies, mosquitoes and gnats) within a few hours. One can protect an area up to 170 cubic metres for up to 30 days.

**USE AREAS:** Attics, Garages, Outdoor Storage Buildings, Horse Stables, Crawl spaces such as in basement areas. Use area must have at least 170 cubic metres of free flow air space.

***DO NOT INSTALL IN THE LIVING AREAS OF THE HOME SUCH AS THE KITCHEN, BEDROOM OR LIVING ROOM.***

**DIRECTIONS:** In areas where ceilings are approximately 3 metres high the dispenser should be located 2-2.5 metres above the floor at a point where air circulation will carry particles throughout the area. In areas where the ceilings are low, such as attics & crawl spaces, install the dispenser approximately 0.5 metre from the ceiling. Do not install directly over food or food packaging surfaces. To install can, remove protective cap and screw into dispenser.

**PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN.** Contents under pressure. Container may explode if heated. Do not expose to temperatures above 50° C. Do not puncture or incinerate. Do not contaminate food, feed or water. Avoid contact with skin and inhalation of spray mist. Wash hands after using. Contents toxic to fish and birds. Do not install directly over polished, plastic, or varnished surfaces such as cars or cabinets.

**DISPOSAL:** When container is empty, press valve to release all remaining pressure. Dispose of empty container in household garbage.

**FIRST AID TREATMENT:** In case of contact with eyes: Hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. In case of contact with skin or clothing: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice. If ingested: Call a poison control centre or doctor immediately for treatment advice. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give any liquid to the person. Do not give anything by mouth to an unconscious person. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.
