DIRECTIONS FOR USE:

To be used only in the manufacture of a pool product which is registered under the PEST CONTROL PRODUCTS ACT. Registrants are responsible for their own registrations

PRECAUTIONS:

KEEP OUT OF REACH OF CHILDREN. PREVENT ACCESS BY UNAUTHORIZED PERSONNEL. Dangerous gas formed when mixed with acid. Do not mix with any other chemical. Strong oxidizing agent. If in eyes: Hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.
