This product contains a liquid bait which attracts ants that will then take it to their nests to feed larvae and queens. The whole colony is destroyed by SUPER ANT KILLER within several days.

**DIRECTIONS FOR USE**: Apply as a spot or crack and crevice application only. A spot application is an open, localized placement of bait in areas inaccessible to children and pets. Locations of treatment may include under sinks and under heavy appliances (e.g., fridge or stove). Crack and crevice is an application directly into narrow openings on the surface of the structure. It does not include the treatment of exposed surfaces. Narrow openings typically occur at expansion joints, utility entry points and along baseboards and mouldings.
