DIRECTIONS FOR USE: Periodically disinfect the tapping bit by immersing it in DA-2J for 2 seconds. Immediately before inserting it in the tap hole, spray the interior and exterior of the spout with 2 mL of DA-2J with a spray bottle. After use, wipe the nozzle of the spray bottle and tighten to close. It is recommended to throw out the first sap flow after the application of the product.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Harmful if swallowed or inhaled. Avoid contact with skin, eyes and clothing, as well as inhalation of spray mist. Goggles and/or face mask, long sleeved shirt, long pants, and footwear must be worn when mixing, loading and applying the product. Wash thoroughly with soap and water after use. Ingestion: Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.
