# **DIRECTIONS FOR USE:**

To be used only in the manufacturing, formulation or repackaging of a pest control product registered under the *Pest Control Products Act*.

#### PRECAUTIONS:

PREVENT ACCESS BY UNAUTHORIZED PERSONNEL. Avoid contact. Wash thoroughly after using or before eating, drinking or smoking. Wear clean protective clothing, including chemical resistant gloves, goggles and respirator when handling manufacturing product.

#### FIRST AID:

If swallowed: Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person. If in eyes: Hold eye open and rinse slowly and gently with

If in eyes: Hold eye open and rinse slowly and gently with water for 15 to 20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

If on skin or clothing: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice.

If inhaled: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

#### TOXICOLOGICAL INFORMATION:

Administration of gastric lavage with activated charcoal is recommended. Atropine Sulphate should only be administered in case of obvious cholinesterase inhibition. The treatment of intoxication should be symptomatic and supportive after appropriate decontamination.

#### STORAGE:
