#### **DIRECTIONS FOR USE:**

1.

- Initial dosage for pool water having no visible algae is 130 mL of AQUA CHEM ALGAECIDE CONCENTRATE per 10,000 L of pool water.
- 2. Weekly maintenance dosage is 455 mL of AQUA CHEM ALGAECIDE CONCENTRATE per 10,000 L of pool water.
- 3. For pool water having visible algae, superchlorinate following instructions of superchlorination product employed and wait for at least 24 hours before adding weekly maintenance dosage.

4. For visible algae, when super-chlorination is not employed, add 200 of AQUA CHEM ALGAECIDE CONCENTRATE per 10,000 L of pool water 10,000 L of pool water.
