DIRECTIONS FOR USE:

This product is to be applied directly to the horse/pony as a spray or as a wipe-on. Prior to treatment, thoroughly brush horse/pony to remove excess dirt and dust and remove mucous secretions from face of the horse/pony. Extremely dirty horses should be shampooed, rinsed and allowed to dry before treatment.

HOLD CONTAINER UPRIGHT. SHAKE WELL BEFORE USING. Ready to use. No mixing necessary. This product is to be applied directly to the horse/pony as a spray or as a wipe-on. **DO NOT** apply as a space spray.

SPRAY METHOD:

Apply a light, uniform spray to thoroughly coat the hair of the horse/pony while brushing lightly against lay of the hair. **DO NOT** wet horse's/pony's skin. WIPE ON METHOD:

Use this method to apply to the face and other sensitive areas to avoid application to eyes and mucous membranes (e.g., nose, mouth, genitals). To use as a wipe-on, moisten (not to the point of dripping) a clean soft cloth/sponge/mitt with ABSORBINE ULTRASHIELD® EX. Thoroughly rub the moistened cloth/sponge/mitt over the area of hair of the horse/pony to be protected. It is best to apply by rubbing against the hair growth. Give/Pay special attention to the legs, shoulders, shanks, neck and facial areas where flies most often are seen on the horse/pony. After application, brush thoroughly to bring out bright sheen on the coat.
