DIRECTIONS FOR USE: SHAKE WELL BEFORE USING. Hold can 90 cm from surfaces to be treated. Be sure to apply uniformly using a sweeping motion to carpets, rugs, drapes, and upholstered furniture in areas where pets typically reside. Avoid contact with treated surfaces until dry. Do not use as a space spray. Do not spray wood surfaces, as water spotting may occur. A fine mist applied uniformly is all that is necessary to kill fleas and ticks. Avoid wetting furniture and carpeting. Re-treat as necessary. Be sure to treat pet bedding and other resting places, as these are primary hiding places for fleas and ticks. No need to remove pet bedding after treatment. DO NOT USE ON PETS.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Avoid breathing mist. May be harmful if swallowed or inhaled. Avoid contact with skin, eyes or clothing. Wash thoroughly after using. When used in the house, all food processing surfaces and utensils should be covered during treatment. Cover exposed food. Do not apply while processing, preparation, or serving is underway. If in eyes, hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre

or doctor for treatment advice. **If swallowed**, call a poison control centre or doctor immediately for treatment advice. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give **any** liquid to the person. Do not give anything by mouth to an unconscious person. Take the container label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION: Treat symptomatically.

STORAGE & DISPOSAL: Store in a cool area. When container is empty, press valve to release all remaining pressure. Dispose of empty container with household garbage. Do not puncture or incinerate.
