### DIRECTIONS FOR USE:

#### OILFIELD APPLICATIONS:

Inject continuously at 100 ppm active ingredient based on water content of system until control is achieved. Maintenance dosage 10-25 ppm.

#### PAPER MILLS:

ControlChem 2663 Liquid Microbicide should be used at 0.6-1.0 kg per tonne of dry paper produced at least once per day.

#### HEAT EXCHANGERS, COOLING TOWERS, CONDENSERS AND AIR WASHERS:

Pre-clean heavily fouled system (e.g. with chlorine) shock dosage of 100 ppm active ingredient based on water content of system.

Maintenance Dosage: 10-25 ppm. Not for use in portable water systems.

#### PASTEURIZER COOLING WATER SYSTEM:

Avoid contamination of food in application of the product. Shock dosages of 100 ppm of active ingredient should be added to the closed recirculating system at a convenience point of uniform mixing such as basin sump area or other reservoir from which the 2013-5492

treated water will be circulated uniformly throughout the pasteurizer cooling system. Maintenance Dosage: 10-25 ppm. Not for use in portable water system.

#### METAL WORKING FLUIDS:

ControlChem 2663 Liquid Microbicide should be injected at 5-10 kg per 10000 L of system volume.

#### PRESERVATIVE:

ControlChem 2663 Liquid Microbicide should be used at rate 2-10 % for bacterial control in Latex emulsions, Polymer Lattices and Adhesives.

#### ENVIRONMENTAL HAZARDS:

This product is toxic to fish and other aquatic organisms. It is not to be used in circumstances that would cause or allow it to enter lakes, streams, ponds, estuaries, oceans or other waters in contravention of federal or provincial regulatory requirements.
