**PRECAUTIONS:**

**KEEP OUT OF REACH OF CHILDREN AND PREVENT ACCESS BY UNAUTHORIZED PERSONNEL. DANGER - CORROSIVE TO EYES.** Causes severe eye and skin damage. Do not get in eyes, on skin or on clothing.
