A penetrating, ready to use solution for protecting wood against rot and mildew.

DIRECTIONS FOR USE: For exterior use only. Not for use in dwellings. For above ground use only. Apply by brush only. Do not spray or dip. Wood surface to be treated should be dry and clean. Remove all paint, varnish, wax or any other coating that may prevent penetration. Allow to dry thoroughly before painting or re-coating. Use as supplied. Do not dilute. Do not apply to wood or any surface where prolonged skin contact may occur, or on any surface which may come into contact with food, feed or drinking water. Clean equipment (brushes, trays, etc.) with mineral spirits, then with detergent and water. Harmful to plant life when wet. Allow to dry thoroughly before permitting contact. Apply as much solution as will readily soak in. If rotting conditions are severe, allow to dry thoroughly before applying a second coat by brushing only. Allow 72 hours to dry. DO NOT contaminate irrigation or drinking water supplies or aquatic habitats by cleaning of equipment or disposal of wastes.

WOOD: 1 litre treats 15 sq. metres of rough lumber or 20 sq. metres of finished lumber.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Flammable. Do not use or store near open flame or spark or in areas subject to excessive heat. Harmful if swallowed or inhaled. Causes skin and eye irritation. Potential skin sensitizer. Avoid, breathing vapours, contact with skin, eyes and clothing. Wear a long-sleeved shirt, long pants, socks, shoes and rubber gloves when applying this product. Wash thoroughly after use with soap and water and before eating or smoking. Keep container closed when not in use. Use only under well ventilated conditions.

FIRST AID: If in eyes, hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. If swallowed, call a poison control centre or doctor immediately for treatment advice. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give **any** liquid to the person. Do not give anything by mouth to an unconscious person. In case of contact with skin or clothing, take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20

minutes. Call a poison control centre or doctor for treatment advice. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION: Contains petroleum distillates and zinc naphthenate. Treat as for ingestion of kerosene.

ENVIRONMENTAL HAZARDS: toxic to aquatic organisms

DISPOSAL & STORAGE: Do not reuse empty container. Dispose of empty container in household trash. Store unused product out of reach of children or animals.
