## **DIRECTIONS FOR USE:**

- 1. Initial dosage for pool water having no visible algae is 100 mL of this product per 10,000 L of pool water.
- 2. Weekly maintenance dosage is 35 mL of this product per 10,000 L of pool water.
- 3. For pool water having visible algae, superchlorinate following label instructions of superchlorination product employed and wait at least 24 hours before adding weekly maintenance dosage.
- 4. For visible algae, when superchlorination is not employed, add 150 mL of this product per 10,000 L of pool water.
