**DIRECTIONS FOR USE: Space Spraying:** For control of flies, fruit flies, gnats, mosquitoes, wasps, hornets, food and flour moths. Close doors and windows. Apply with sprayer adjusted to deliver a fine mist. Directly spray upwards and uniformly throughout entire area. Ventilate rooms 15 minutes after treatment. **Surface Spraying:**

To control cockroaches, ants, silverfish, spiders, crickets, clover mites, grain and flour beetles or weevils. Adjust sprayer to deliver a coarse, wet spray. Apply into cracks and crevices, around appliances, behind shelves and drawers and other hiding places. In case of infested foods in cabinets, dispose of the infested materials. Remove all contents and clean thoroughly. Spray interior surfaces of empty cabinets thoroughly. After spray has dried, cover shelves with paper or otherwise protect foods from direct contact with sprayed surfaces. Repeat treatment if reinfestation occurs. For ants, spray trails, nests and points of entry. All sprayed surfaces should be thoroughly wetted.

**GARDEN PESTS on FLOWERS and ORNAMENTALS:** To control aphids, flea beetles, leafhoppers, white flies, spider mites, rose chafers, tarnished plant bugs. Apply a fine mist spray to upper and lower leaf surfaces. Use with caution on young plants and new growth. Repeat treatments weekly or as needed.

**PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN.** Avoid breathing spray mist. Avoid contact with skin, eyes, feed or food. Remove pets, birds and cover or remove aquariums, food and food utensils before spraying. Do not reuse container.

**FIRST AID:** If on skin or clothing, take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice. If in eyes, hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. If swallowed, call a poison control centre or doctor immediately for treatment advice. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give any liquid to the person. Do not give anything by mouth to an unconscious person. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

**TOXICOLOGICAL INFORMATION:** Treat symptomatically.

**DISPOSAL:** Do not reuse empty container. Dispose of in household garbage.
