DIRECTIONS FOR USE

This formulation is for use in commercial and industrial site by Pest Control Operators. It may be used in and around the home and non-food areas of: Schools, Warehouses, Office Buildings, Apartment Buildings, Theatres, Hotels, Motels, Kennels, Truck Trailers, Railroad Cars and Warehousing Establishments.

WARM TO ROOM TEMPERATURE AND MIX WELL BEFORE USE

FOR INDOOR PESTS:

GENERAL: Use EVERCIDE® Concentrate 2506 to control the pests indicated in the listed areas by mixing 85 grams of concentrate in 3.8 liters of water and mix thoroughly before use. For all applications, use this spray at the rate of 3.8 liters (diluted spray) per 93 square meters of surface area.

FOR PREMISE PESTS:

GENERAL: Apply as a coarse wet spray to thoroughly treat hiding places, such as cracks, crevices and moist areas around pipes, under refrigerators and along baseboards to control pests listed below. Use at the rate of 3.8 liters of spray mixture per 93 square meters. Spray directly on insects when possible. Do not permit humans or pets to contact treated surfaces until the spray has dried. Do not retreat before 2 weeks.

To kill Ants, Carpet Beetles, Centipedes, Cockroaches, Crickets, Silverfish, Sowbugs and Spiders: Spray areas where these pests are found or may hide, including dark corners of rooms and closets; cracks and crevices in walls; along baseboards and door and window frames; behind and beneath sinks, stoves, refrigerators and cabinets and around garbage cans, plumbing and other utility installations. Pests driven out of hiding places should be sprayed directly. For Ants, apply to ant trails, also around doors and windows and wherever these pests may find entrance. Do not retreat before two weeks.

To Kill Brown Dog Ticks and Fleas: For control of Brown Dog Ticks, thoroughly apply as a spot treatment to infested areas such as pet beds and resting quarters, boards, window and door frames and localized areas of floor and floor coverings where these pests may be present. For control of Fleas, thoroughly apply a fine particle broadcast spray, using the 85 grams per 3.8 liters of water dilution to infested rugs, carpets, and pet resting areas. Prior to treatment, aquariums and fish bowls should be covered and birds, such as canaries, removed from the area. **DO NOT PERMIT HUMANS OR PETS TO CONTACT TREATED SURFACES UNTIL THE SPRAY HAS DRIED.** Old bedding should be removed and replaced with clean, fresh bedding after treatment. **DO NOT SPRAY PETS WITH THIS PRODUCT.** Treat dogs and cats with a product registered for use on animals.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Harmful if swallowed or absorbed through skin. Do not breathe vapors or spray mist. Wear mask or respirator when applying spray mist. Avoid contact with skin and eyes. Do not contaminate food or feedstuffs. This product is toxic to fish and other aquatic invertebrates. Keep out of lakes, streams or ponds. Do not contaminate water by cleaning of equipment or disposal of wastes.

FIRST AID: In case of contact with eyes, hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. In case of contact with skin or clothing, take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice. If swallowed, call a poison control centre or doctor immediately for treatment advice. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give any liquid to the person. Do not give anything by mouth to an unconscious person. If inhaled, move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION: Treat Symptomatically.

STORAGE: Keep container closed. Mix well in drum before sampling and each use. Store in a cool, dry place. Do not store, pour or spill near heat or open flame.

DISPOSAL & DECONTAMINATION: Do not reuse this container for any purpose. This is a recyclable container, and is to be disposed of at a container collection site. Contact your local distributor/dealer or municipality for the location of the nearest collection site. Before taking the container to the collection site:

1. Triple- or pressure-rinse the empty container. Add the rinsings to the spray mixture in the tank. 2. Make the empty, rinsed container unsuitable for further use. If there is no container collection site in your area, dispose of the container in accordance with provincial requirements.
