If swallowed, absorbed or in haled by humans, domestic animals or pets, this material would likely cause num bness, incoordination and respiratory distress. If ingested, limit absorption by either em esis or gastric lavage. Sublethal sym ptoms, if present, would be the result of cerebral edema and should be treated accordingly through admission of an osmotic diuretic and corticosteroid.

STORAGE: Keep in original container during st orage. Store product in cool, dry, well ventilated place away from seed, feed, fertilizer, or other pesticides. Keep away from fire or open flame, or other source of heat.
