DIRECTIONS: Apply sparingly not under clothing and only when necessary. Reapply after 3 hours if necessary. TO APPLY TO FACE: Spray hands and apply avoiding eyes and mouth. Do not spray in enclosed spaces.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Supervise applications on children. DO NOT USE ON INFANTS UNDER 6 MONTHS OF AGE. In 6 month to 2 year olds, do not apply more than once a day. Not for daily use. Avoid application to hands. In 2 to 12 year olds, do not apply more than three times a day. Avoid contact with eyes and mouth, rayon, dynel, acetate, plants, furniture finishes, plastics and painted surfaces. CONTENTS UNDER PRESSURE. Do not place in hot water or near radiators, stoves, or other sources of heat. Do not puncture or incinerate container or store at temperatures over 50°C. Keep away from open flame or spark.

**FIRST AID:** If irritation or other adverse effects develop, wash with soap and water immediately. Seek medical attention if symptoms persist. Always take container with you when seeking medical attention. **IF IN EYES,** hold eye open and rinse slowly and gently with water for 15–20 minutes.
