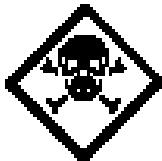

DIRECTIONS FOR USE: This product is to be used only in the manufacture of a microbiocide which is registered under the Pest Control Products Act.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. DANGER! CORROSIVE. CAUSES SEVERE EYE AND SKIN BURNS. MAY BE FATAL IF INHALED. AVOID CONTACT WITH SKIN, EYES AND CLOTHING.

Do not breath vapour or mist. Use only with adequate ventilation. Keep container closed. Keep away from heat and flame. Do not contaminate food. Wear goggles or face shield, chemical-resistant gloves, long pants, a long sleeved shirt, and shoes plus socks during mixing/loading, clean up and repair. Discard clothing or other absorbent materials that have been drenched or heavily contaminated with this product's concentrate. Do not reuse them. Users should wash hands before eating, drinking, chewing gum, using tobacco or using the toilet. Users should remove clothing immediately if pesticide comes into contact with skin through soaked clothing or spills. Then wash skin thoroughly and put on clean clothing. Wash contaminated clothing separate from other laundry before reuse.

FIRST AID: Eye contact: Hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

Skin or clothing contact: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice.

If swallowed: Call a poison control centre or doctor immediately for treatment advice. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give any liquid to the person. Do not give anything by mouth to an unconscious person.

If inhaled: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

Take the container label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION: Contains heavy aromatic naphtha (Petroleum Distillate). There is no specific antidote. Probable mucosal damage may contraindicate use of gastric lavage. Measures against circulatory shock, respiratory depression, and convulsion may be needed.

ENVIRONMENTAL HAZARDS: This product is toxic to fish and other aquatic organisms. It is not to be used in circumstances that would cause or allow it to enter lakes, stream, ponds, estuaries, oceans or other waters in contravention of federal or provincial regulatory

requirements. The requirements of applicable laws should be determined before using the product. Open dumping is prohibited.

STORAGE: Container should be stored in a cool, dry, well-ventilated area away from flammable materials and sources of heat and flame. Avoid prolonged storage at temperatures above 70°C. Keep container tightly closed when not in use. Exercise due caution to prevent damage to or leakage from the container. Do not reuse empty container.

DISPOSAL: Do not reuse this container for any purpose. For disposal, this empty container may be returned to the point of purchase (distributor/dealer).
