### DIRECTIONS FOR USE

Hartz® UltraGuard Plus® Flea & Tick Home Spray kills adult and pre-adult fleas in the home. It contains a unique combination of two insect control ingredients, permethrin and Precor. The permethrin kills adult fleas, brown dog and American dog ticks. Precor, an insect growth regulator, breaks the flea life cycle by preventing the flea's development into the adult biting stage. This product is designed for use on carpeting, however, some natural fibres (such as wool) and synthetics may be adversely affected by any liquid product – always test a hidden area prior to use. Care should be used when treating wood surfaces, as water spotting may occur. Users should test a small, inconspicuous area first to ensure there are no adverse effects such as staining or discolouration. Good sanitary practices should be maintained to prevent re-infestation. One 473mL bottle will treat a structural surface area of 18.5m² (200 ft²).

SHAKE WELL BEFORE USING. Adjust the spray nozzle to create a fine mist and apply uniformly without wetting furniture and carpeting. Do not use as a space spray. Be sure to treat pet bedding and other resting places. No need to remove pet bedding after treatment. If pest problems persist, a second application 2 - 3 weeks after the initial treatment may be necessary. DO NOT TREAT PETS WITH THIS PRODUCT.

Ticks must be hit by spray to be killed. For effective flea and tick control, pets should be treated with a registered flea and tick control product designed for use on pets, and treatment of the pet must be combined with the sanitation of any area used by the pet. Vacuum floors, carpets and furniture (discard vacuum bag after use) and wash the pet's bedding, living quarters and surrounding areas prior to treatment with this product. If pest problems persist, an insecticidal treatment of the premises may be required. A veterinarian should be consulted when flea infestation continues to be a problem on the pet.

**Restrictions:** FOR INDOOR USE ONLY. DO NOT contaminate food/feed. DO NOT apply to surfaces that may come into contact with food/feed. DO NOT apply when people or pets are present. DO NOT allow people or pets to enter treated areas until sprays have dried. DO NOT allow spray to drip or allow drift onto non-target surfaces. DO NOT apply to people, pets, or sources of electricity. Remove pets and birds, and cover or remove fish tanks or bowls. DO NOT apply to furniture, mattresses, linens, toys or clothing. DO NOT apply to overhead areas or in confined spaces (for example, attics, crawlspaces, small storage rooms, closets). Ventilate treated areas after application by opening windows and doors or using fans where required to aid in the circulation of air.

DO NOT apply indoors as a broadcast application. ONLY perimeter, spot or crack and crevice applications are permitted indoors in residential areas. Indoor perimeter application is less than 0.3 m wide along the edges of a room to baseboards, wall-floor and ceiling-wall joints, and around doorways or windows. Spot application is localized to a surface area not more than 0.2 m2. Spots are not to be adjoining. The combined area of spots is not to exceed 10% of the total surface area of a room. Crack and crevice is an application directly into narrow openings on the surface of the structure. It does not include the treatment of exposed surfaces. Narrow openings typically occur at expansion joints, utility entry points and along baseboards and mouldings.

### **PRECAUTIONS**

KEEP OUT OF REACH OF CHILDREN. May be harmful if swallowed or absorbed through skin. Avoid breathing spray. Avoid contact with skin, eyes or clothing. Wash thoroughly after handling. Do not spray on animals, humans, plants, foodstuffs, food utensils, fish bowls or animal feed areas. Thoroughly wash all surfaces that might be in contact with food before re-use. This product contains a petroleum distillate which is moderately to highly toxic to aquatic organisms. Avoid contamination of aquatic systems during application. Do not contaminate these systems through direct application, disposal of waste or cleaning equipment.

#### **FIRST AID**

Take container, label, or product name and Pest Control Product Registration Number with you when seeking medical or veterinary attention.

**If on skin or clothing:** Take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice.

If in eyes: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if

present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

**If swallowed:** Call a poison control centre or doctor immediately for treatment advice. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give any liquid to the person. Do not give anything by mouth to an unconscious person.

**If inhaled:** Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.
