DIRECTIONS: SHAKE WELL BEFORE USING. Hold can upright before spraying.

TO KILL GARDEN PESTS: Carefully spray with slow sweeping motion keeping 30 cm to 45 cm away from the plants to avoid wetting the foliage. A light spray kills pests effectively. Upper and lower leaf surfaces should be treated. Spray only when air is still and temperature is under 32°C. Do not spray in direct sunlight, early morning or evening preferred. Use with caution on young plants and new growth. Insects must be contacted by spray to be killed.

Sucking Insects: Exposed thrips, leaf-hoppers, spotted mites, lace bugs, aphids, white-flies.

Chewing Insects: Caterpillars, climbing cutworms, Japanese beetles, flea beetles, Cucumber Beetles, Cabbage Loopers, Armyworms.

ON FLOWERS AND ORNAMENTALS: For insects on Asters, Azaleas, Begonias, Chrysanthemums, Dahlias, Delphiniums, Gladiolas, Irises, Marigolds, Petunias, Roses, Snapdragons, Evergreens, small Deciduous trees, Shrubs and Vines.

ON VEGETABLES: For insects on cabbage, carrots, tomatoes, potatoes, broccoli, onions, beans, beets, peas, cucumbers, turnip, lettuce, squash, fruit trees, grapevines, asparagus.

ON HOUSE PLANTS: Kills Aphids, Spotted Mites, Exposed Thrips, Leafhoppers, Climbing Cutworms, Caterpillars, Adult Whiteflies on Houseplants such as English Ivy, African Violets, Impatiens, Geraniums, Begonias.

NOTE: Do not spray fruit or vegetables within 3 days of picking. Wash fruit and vegetables before eating.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Contents under pressure. Do not place in hot water or near radiators, stoves or other sources of heat. Do not puncture or incinerate container, or store at temperatures over 50°C. Do not spray closer than 1 m to fabric. Do not spray near open flame or spark, or while smoking. Do not contaminate any body of water. Avoid contact with skin, eyes, clothing. Avoid inhalation of spray. Wash after using. Keep from freezing. Do not use on Maiden hair ferns.

DISPOSAL: When container is empty, press valve to release all pressure. Wrap and dispose of empty container in household garbage.

FIRST AID: If in eyes, hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. If on skin or clothing, take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice. If swallowed, call a poison control centre or doctor immediately for treatment advice. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give any liquid to the person. Do not give anything by mouth to an unconscious person.
