DIRECTIONS FOR USE:

TO CONTROL MICROBIAL CONTAMINATION FOR COMPOUNDERS: Add Onyxide 200 Preservative to the concentrate, in order to obtain 638 ppm in the final dilution. **DO NOT** contaminate irrigation or drinking water supplies or aquatic habitats by cleaning of equipment or disposal of wastes.

FOR END-USERS: Add 638 ppm Onyxide 200 Preservative to the use dilution of the metalworking fluid at regular intervals.

DISPOSAL:

1. Triple- or pressure-rinse the empty container. Add rinsings to the treatment site.

3. Make the empty container unsuitable for further use.
