DIRECTIONS FOR USE

For use as a microbicide in exterior latex based paints to prevent mildew defacement of the paint film. Use 0.25 kg to 0.52 kg of this product in 100 kg of paint formulation (500 ppm to 1030 ppm active ingredient). This treatment has been shown to be effective for a period of 36 months.

It is suggested the formulator perform field trials within the label rates to determine the best rate for preservation of their paint. Do not use in the manufacture of paints to be used indoors.

PROHIBITIONS
