DIRECTIONS FOR USE:

To be used only in the manufacture of pesticide registered under the *Pest Control Products Act*.

PRECAUTIONS:

PREVENT ACCESS BY UNAUTHORIZED PERSONNEL. Avoid inhaling dust and use adequate ventilation. Avoid contact with eyes. May cause irritation and soreness in throat and nose in cases of extreme exposure. Some congestion may occur. Use a suitable mask (e.g., NIOSH/MSHA TC- 21C-132) and appropriate eye protection during application. Do not eat, drink or smoke while using this product. Wash hands with plenty of soap and water after treatment.

FIRST AID:

IF SWALLOWED, call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

IF ON SKIN OR CLOTHING, take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice.

IF INHALED, move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

IF IN EYES, hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION:

Low concentrations of silica dust may irritate the respiratory tract and eyes. Treat symptomatically.

STORAGE:

Keep in original container during storage. Store product in cool, dry, well ventilated place away from seed or other pesticides.
