DIRECTIONS FOR USE

To be used only in the manufacture of an insecticide or fungicide which is registered under the Pest Control Products Act.

PRECAUTIONS

PREVENT ACCESS BY UNAUTHORIZED PERSONNEL May be harmful if swallowed or inhaled. Avoid contact with eyes, skin and clothing. Minimize breathing mists or vapors. Use with adequate ventilation. Wash exposed skin thoroughly after using.

MISUSE OF THIS CONTAINER CAN BE HAZARDOUS. Do not cut, weld or apply heat to empty container. Do not pressurize. Store container away from heat or flame. Do not use for storage of anything other than original contents.

FIRST AID:

IF SWALLOWED: Call a poison control centre or doctor immediately for treatment advice. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give **any** liquid to the person. Do not give anything by mouth to an unconscious person.

IF IN EYES: Hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

IF ON SKIN OR CLOTHING: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice.

IF INHALED: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

Take the container label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION: Treat symptomatically. This product contains petroleum distillates. Vomiting may cause aspiration pneumonia.

ENVIRONMENTAL HAZARDS: Toxic to aquatic organisms. Do not discharge effluent containing this product into sewer systems, lakes, streams, ponds, estuaries, oceans, or other waters.

SPILL CONTROL Avoid contact. Eliminate all ignition sources. Ventilate confined spaces. Absorb with an inert material and Place in appropriate waste disposal container.
