DIRECTIONS FOR USE: SHAKE WELL BEFORE USING. Apply with trigger sprayer enclosed.

INDOOR APPLICATION:

For spot application only. Do not use as a space spray or broadcast application indoors.

SURFACE SPRAYING. To control **Cockroaches, Sow bugs, Ants, Silverfish, Firebrats, Spiders, Crickets, Rice Weevils and Red Flower Beetles:** Direct the spray into hiding places, cracks and crevices, behind shelves and drawers, along baseboards, beneath and behind sinks, stoves, refrigerators and cabinets. For **Silverfish,** spray bookcases. For **Ants** spray trails, nests and points of entry. To control **Carpet Beetles:** Spray edges of carpeting and under carpeting and rugs for approximately 10 seconds duration. Make localized application to floor and baseboards. Spray directly into cracks, crevices and infested areas of shelving. Repeat treatment as needed. To control **Fleas** (adult and larvae) and **Ticks** (adult and larvae) : thoroughly spray infested areas, pet beds, resting quarters, nearby cracks and crevices, along and behind baseboards, mouldings, window and doorframes. Apply to infested floor areas as a spot spray only, not as a space or broadcast spray. Fresh bedding should be placed in animal quarters following treatment. Repeat treatment as needed. Allow to dry thoroughly before allowing pets to contact treatment areas. To control **Clothes Moths:** Remove any infested articles from storage, brush thoroughly and air for several hours in sunlight, if possible. Apply spray liberally to empty chests, closets, bureaus and other storages directing the spray into cracks, joints and crevices. After airing, infested articles may be treated lightly, keeping nozzle at least 90 cm (3 ft) from fabric to avoid staining. Allow articles to dry before handling and launder clothes before wearing.

OUTDOOR APPLICATION:

Ants, Crickets, Fleas, Spiders, Sow bugs and Ticks: For treatment of localized infestations on patios, decks and non crop areas, spray infested areas thoroughly. For **ants,** thoroughly treat hills and runways. Repeat application if reinfestations occur. Vinyl and Aluminum Siding: The application of this product to vinyl and aluminum siding (particularly lightly colored, aged, weathered or otherwise damaged,) may result in staining, bleaching or discoloration. Factors such as extreme heat and direct sunlight can promote damage. Before applying to vinyl or aluminum siding, treat a small area and evaluate 30 minutes later to allow any potential staining to occur. Regardless of the test results, do not apply to vinyl or aluminum siding while exposed to direct sunlight or during the heat of the day.

Directions for use of trigger sprayer:

1. Remove sprayer from re-usable bag. Put on plastic gloves.
2. Unscrew cap from container and retain in plastic bag.
3. Place tube through hole in cap, then insert tube into bottle and screw on cap.
4. Open nozzle about one turn.
5. Point sprayer at desired area, and pump trigger until spray begins.
6. Adjust nozzle as desired ... fine stream for spot treatment, wide mist for broad application.
7. When temporarily not in use, keep trigger sprayer above liquid level of container to prevent leakage from nozzle.
8. To store, remove sprayer and carefully drain tube into bottle by squeezing trigger. Re-cap container with original cap.
9. Rinse sprayer tube and gloves with clear water before storing in the plastic bag supplied.

NOTE: Trigger Sprayer is to be used only for this product.

REMEMBER ... ALWAYS STORE PESTICIDES, CAPS, SPRAYERS AND RELATED EQUIPMENT OUT OF REACH OF CHILDREN AND PETS.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN . Wash thoroughly after handling and before smoking or eating. Avoid contamination of food, feed, cooking utensils or drinking water. Remove pets and birds and cover fish aquarium before surface applications. After use and at least one (1) hour drying time, wash all surfaces that may contact food. Do not use on humans. Do not allow people or pets to contact treated areas until surfaces are dry. This product is extremely toxic to fish and aquatic invertebrates. Do not apply directly to lakes, rivers, streams, ponds, tidal marshes and estuaries. Do not contaminate the above mentioned aquatic areas through spray drift, cleaning of equipment or disposal of waste.

FIRST AID: If in eyes: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. **If on skin or clothing:** Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice. **If swallowed:** Call a poison control centre or doctor immediately for treatment advice. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give any liquid to the person. Do not give anything by mouth to an unconscious person. Take container label or product name and P.C.P. Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION:

This product contains petroleum distillates. Vomiting may cause pneumonia aspiration. Treat symptomatically.

DISPOSAL: Do not reuse empty container. Wrap empty container and discard in household garbage.
