DIRECTIONS FOR USE:

To be used only in the manufacture of a pesticide which is registered under the PEST CONTROL PRODUCTS ACT.

PRECAUTIONS:

KEEP PRODUCT OUT OF REACH OF UNAUTHORIZED PERSONNEL. Strictly observe all precautions for handling and using pesticides. May be harmful if swallowed or absorbed through skin. Extremely irritating and corrosive to eyes. Avoid contact with mouth, skin, eyes and clothing. Wear protective clothing including, coveralls/apron, boots, chemical resistant gloves, face protection, including splash-proof or dust-resistant safety goggles and a chemical cartridge respirator with an organic vapour cartridge when handling, mixing or loading this product. Use in well-ventilated area. Wash thoroughly with soap and water after handling product and before eating, drinking, or smoking. Wash contaminated clothing with soap and water and separate from other laundry before reuse. This product is toxic to fish and wildlife. Keep out of lakes, streams or ponds. Do not contaminate water by the cleaning of equipment or disposal of wastes.

FIRST AID:

IF IN EYES: Flush with clean water for 15 minutes. Get medical attention immediately.

IF ON SKIN: Remove contaminated clothing and wash affected area repeatedly with soap

IF SWALLOWED: Drink one or two glasses of water and induce vomiting by touching back of throat with finger or blunt object. Do not induce vomiting or give anything by mouth to an unconscious person. Apply artificial respiration if indicated. Seek medical attention immediately.

IF INHALED: Remove victim to fresh air. Apply respiration, if necessary.

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION:

Treatment is symptomatic. Although symptoms are nonspecific, they may include exhaustion, muscular spasms, urinary incontinence, dyspnea and cyanosis. For ingestion, lavage stomach with tap water. Instill 30 gm activated charcoal in 90-120 ml (3-4 oz.) of water. Catharsis with 15 gm sulfate in 175-240 ml (6-8 oz.) water.

STORAGE:

Store in the original packaging in a well ventilated room. Store in a cool, dry place away from food, feed or other pesticides. Keep out of reach of unauthorized persons. Protect from sun and humidity. Do not store near heat or open flame.
