DIRECTIONS FOR USE: To be used only in the manufacture of insecticides which are registered under the Pest Control Products Act. This product is to be used with appropriate solvents and/or carriers, and in the case of pressurized products, propellents, to produce an insecticide product.

Do not use in food handling, storage or preparation areas while food is present.

Mix well in drum before sampling and each use.

PRECAUTIONS: KEEP OUT OF REACH OF UNAUTHORIZED PERSONNEL. Harmful if swallowed. Avoid breathing vapors or spray mist. Avoid contact with skin or eyes. In case of contact, flush with plenty of water. Wash with soap and warm water after use. Obtain medical attention if irritation persists. Avoid contamination of food and feedstuffs. This product is toxic to fish. Do not apply directly to any body of water by cleaning of equipment or disposal of wastes. Do not use or store near heat or open flame.

FIRST AID: If on skin or clothing, take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice. In case of contact with eyes, hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. If swallowed, call a poison control centre or doctor immediately for treatment advice. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give any liquid to the person. Do not give anything by mouth to an unconscious person.

ENVIRONMENTAL HAZARDS: Toxic to aquatic organisms.

DISPOSAL & DECONTAMINATION: Rinse empty container and add rinsings to formulation tank, if possible.
