#### DIRECTIONS FOR USE:

To be used only in the manufacture of insecticides which are registered under the Pest Control Products Act. MULTICIDE® Mix 2167 is designed for use at the rate of 1.43% (wt.) with appropriate carriers, etc. to produce pressurized or liquid plant sprays or at the rate of 2.50% (wt.) to produce pressurized or liquid pet sprays. Read technical bulletin for formulation details.

#### PRECAUTIONS:

KEEP OUT OF REACH OF UNAUTHORIZED PERSONNEL. May be fatal if swallowed or absorbed through skin. Do not breathe vapors. Causes eye and skin irritation. Avoid contact with eyes or skin. Avoid contamination of food and feedstuffs.

#### FIRST AID:

In case of spillage on skin or clothing, take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice. In case of contact with eyes, hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give any liquid to the person. Do not give anything by mouth to an unconscious person.
