Shake well before using. Spray upwards in sweeping motion to all parts of the room. Spray 5 to 10 seconds for average room. Direct mist into areas where insects are present. Vacate for at least 15 minutes immediately after spraying and aerate before re-entering. Do not use tetramethrin in food handling, storage or preparation areas while food is present. Use only for spot or crack and crevice applications. Residential areas are defined as any use site where the general public, including children, could be exposed during or after application. For structural uses, in residential sites, this includes homes, schools, restaurants, public buildings or any other areas where the general public including children may potentially be exposed. Non-residential areas include, but are not limited to: industrial/commercial indoor sites (for example, laboratories, warehouses, food granaries); modes of transport in areas where passengers are not present (for example, buses, railcars, trailers); and animal housing (for example, livestock housing and poultry, pet kennels).

FIRST AID: For contact on skin or clothing, take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice. If in eyes, hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. If swallowed, call a poison control centre or doctor immediately for treatment advice. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give **any** liquid to the person. Do not give anything by mouth to an unconscious person. If inhaled move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to mouth, if possible. Call a poison control centre or doctor for further treatment advice. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.
