**DIRECTIONS FOR USE:**

This product is to be used only in formulating products registered under the Pest Control Products Act or the Fertilizers Act.

**PRECAUTIONS:**

1. PREVENT ACCESS BY UNAUTHORIZED PERSONNEL.
2. Harmful if swallowed or inhaled
3. Avoid inhalation of dust. May cause irritation of the skin. Avoid contact with skin, eyes and clothing.
4. During mixing and/or blending operations, wear a hat or other suitable head covering, a long sleeved shirt and long-legged trousers or a coverall-type garment (all of closely woven fabric covering the body, including the arms and legs), shoes, socks, and impervious (rubber or neoprene) gloves.
5. DO NOT discharge effluent containing this product into sewer systems, lakes, streams, ponds, estuaries, oceans or other waters.

**FIRST AID INSTRUCTIONS:**

**IF SWALLOWED:** Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

**IF IN EYES:** Hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

**IF ON SKIN OR CLOTHING:** Take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice.

**IF INHALED:** Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

**PROCEDURES FOR HANDLING SPILLS OR CONTAINER BREAKAGE:**
