PRECATIONS

GENERAL PRODUCT INFORMATION

GLYFOS[®] Concentrate 356 Herbicide is a non-selective herbicide . It controls most annual and perennial grasses, including lawn grasses, broadleaf weeds and brush (i.e. virtually anything that is green and growing). It is absorbed by the leaves and moves throughout stem and roots to control the entire plant. Mature perennial weeds should be treated after seed head, flowers or fruit appear. All plants are most easily controlled in the young, actively growing, seedling stage.

GLYFOS® Concentrate 356 Herbicide wilts and browns plant within 48 hours. Plants usually dry up within 7 days. GLYFOS Concentrate 356 Herbicide, has no soil activity and will not run off to affect nearby vegetation. To ensure that GLYFOS® Concentrate 356 Herbicide gets down to the roots, avoid tillage or disturbing the treated area for 7-10 days after treatment or as directed below. Make sure to contact only those plants that you want to kill. GLYFOS® Concentrate 356 Herbicide will damage or kill any desirable plants it contacts. Use a repeat application on any seedlings that re-grow from seeds.

DIRECTIONS FOR USE

Mix 40 mL of GLYFOS® Concentrate 356 Herbicide in 2 L of water. Apply the 2 L of the spray solution to 40 m². (2 paces by 20 paces or 4 paces by 10 paces) or apply to wet the leaves and stems but not to runoff.

Patios, Driveways, Around Trees and Fence Posts, Along Fence Lines and Edges of Lawns: Apply to young growing vegetation if possible. When spraying around trees take care not to contact leaves or young green bark.

Lawn & Garden Renovation: To kill grasses such as quack grass and other undesirable species in lawns and ornamental and vegetable gardens, apply at rate described above. In lawns apply only to the area where control is desired. Drift or application to desirable plants or grasses around the target area will be killed. Allow 3 days before disturbing the soil or replanting. This will ensure time for the product to penetrate and kill the roots. This container will treat up to 500 m² (500mL), 1000 m² (1 L).

Brush Control: Apply at rate described above. Wet leaves, but do not apply to run off Apply when leaves are fully expanded. Cut back growth to 1.5 m before treatment. Contact all leaves and green bark.

CAUTION: Avoid spray contact on desirable plants as any plant contacted may be killed. Do not spray in windy conditions. Do not spray to the point of run-off. Heavy rainfall immediately after application may wash the chemical off the foliage and repeat treatment may be required. Do not apply if rainfall is forecast for the time of application.
