- 1. Initial dosage for pool water having no visible algae is 50 mL of Cristal Clair 40 % Liquid Algaecide per 10 000 litres of pool water.
- 2. Weekly maintenance dosage is 25 mL of Cristal Clair 40% Liquid Algaecide per 10 000 litres of pool water.
- 3. For pool water having visible algae, superchlorinate following label instructions of superchlorination product employed and wait for at least 24 hours before adding weekly maintenance dosage.
- 4. For visible algae, when superchlorination product is not employed, add 125 mL of Cristal Clair 40% Liquid Algaecide per 10 000 litres of pool water.
