DIRECTIONS FOR USE:

To be used only in the manufacture of a microbiocide which is registered under the Pest Control Products Act.

BTC 2125M P40 in recommended use dilution is non-corrosive to inanimate hard surfaces

DO NOT MIX WITH SOAP OR ANIONIC MATERIALS.

PRECAUTIONS:

DANGER-CORROSIVE. KEEP OUT OF REACH OF CHILDREN AND PREVENT ACCESS BY UNAUTHORIZED PERSONNEL. Causes severe eye and skin damage. Do not get in eyes, skin or clothing.
