DIRECTIONS FOR USE: To be used only in the manufacture of insecticides which are registered under the Pest Control Products Act. 2.00% of this product is to be used with appropriate solvents and or carriers, and in the case of pressurized products, propellents, to produce an insecticide product.

Warm gently to room temperature to liquefy and mix well in drum before sampling and each use.

Do not use in food handling, storage or preparation areas while food is present.

PRECAUTIONS: PREVENT ACCESS BY UNAUTHORIZED PERSONNEL. Harmful if swallowed or absorbed through skin. Contains petroleum distillate. Do not induce vomiting because of aspiration pneumonia hazard. Do not breathe vapors or spray mist. Avoid contact with skin or eyes. Wash thoroughly with soap and water after handling. Avoid contamination of food and feedstuffs. This product is toxic to fish. Do not apply directly to any body of water by cleaning of equipment or disposal of wastes. Do not use or store near heat or open flame.

FIRST AID: If swallowed, call a poison control centre or doctor immediately for treatment advice. Do not induce vomiting unless told to do so by a poison control centre or doctor. Call a poison control centre or doctor for treatment advice. **If inhaled**, move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.
