DIRECTIONS FOR USE:

Maintain recommended daily levels as determined by a testing kit:	
Free available chlorine: 1.0-3.0 ppm	Total Alkalinity: 100-120 ppm
pH: 7.4-7.6	Calcium Hardness 200-300 ppm

For outdoor pools, chlorine residuals can be protected from destruction by the sun's rays by adding 300 grams of **BioGuard® Stabilizer 100** (cyanuric acid) per 10,000 L of pool water to yield the required initial concentration of 30 ppm.

Application Method: Warning. Do not apply this product directly to pool water. Apply slowly through skimmer. Direct contact with pool surfaces may cause bleaching of vinyl, paint or fiberglass. Do not pre-dissolve this product before applying through skimmer. Do not mix this product with any other product or chemicals. Always run pump for 2 - 4 hours after application.

INITIAL STARTUP: Use this method if you are opening your pool in the spring, the pool has not been maintained for several weeks, or if the pool is freshly filled.
