DIRECTIONS FOR USE: To be used only in the manufacture of an insecticide which is registered under the *Pest Control Products Act*.

PRECAUTIONS: Keep out of reach of unauthorized personnel. May be harmful if swallowed or inhaled. Avoid contact with eyes, skin and clothing. Minimize breathing mists or vapors. Use with adequate ventilation. Wash thoroughly after using.

FIRST AID:

IF SWALLOWED: Call a poison control centre or doctor immediately for treatment advice. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give any liquid to the person. Do not give anything by mouth to an unconscious person.

IF IN EYES: Hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

IF ON SKIN OR CLOTHING: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice.

IF INHALED: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

Take the container label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION: This product contains petroleum distillates. Vomiting may cause aspiration pneumonia. Treat symptomatically.

ENVIRONMENTAL HAZARDS: This product is toxic to fish. Do not apply directly to water. Do not contaminate water when disposing of equipment washwater. Apply this product only as specified on the finished product label.

SPILL CONTROL: Avoid contact. Eliminate all ignition sources. Ventilate confined spaces. Absorb with an inert material and place in appropriate waste disposal container. Contain spill.
