PENTOX BROWN is a ready-to-use wood preservative containing propiconazole in petroleum solvents. It is used for the preservation and protection of wood against wood-rotting funging It is an ideal primer-sealer wood preserver. The treated wood can be stained, painted, or varnished, with

conventional exterior finishes. It extends the life of the finish and the service from the wood.

### DIRECTIONS FOR USE

FOR EXTERIOR USE ONLY. Apply by brush only. Do not spray this product. Apply to wood which is not in ground-contact service. Pentox Brown should not be applied if rain is expected soon after application, and before this product would have a chance to dry. Not for use inside dwellings; do not dilute; ready to use. Treat wood that is dry and clean. Painted, sealed and/or varnished wood must be stripped before treatment. Brush in two liberal applications on wood free from all surface deposits, such as paint, oil, dirt, etc. Heavy lumber requires additional brushed-in treatments. If the wood is left unfinished, repeated applications of Pentox Brown (every 2-3 years) are recommended. Treat all surfaces, including those at fastener holes and cuts. Apply 1 liter per 6 to 8 square meters, depending on the porosity of the wood. Give the wood at least an hour to dry before handling it. Allow the wood to dry throughly before staining or painting it - normally six hours. Clean tools with mineral spirits; and then with detergent and water.

### PRECAUTIONS

KEEP OUT OF REACH OF CHILDREN and domestic animals. Keep container closed when not in use. Do not apply to children's - playground structures. Keep away from plants, foodstuffs, and water supplies. It's toxic to fish. Avoid contact with skin, eyes, and clothing. Harmful if swallowed, inhaled, or absorbed through skin. Good ventilation is necessary while treating. Wear chemical resistant gloves during handling. NOT FOR USE IN DWELLINGS, farm buildings, saunas, greenhouses, or on horticultural lumber or food surface areas. Do not use as soil sterilant or herbicide. Not recommended for tents, tarps, fabrics, nor any surface where prolonged skin contact will occur.
