ECONO-CIDE B 1002 is a one-step cleaner that is fungicidal and will prevent the growth of mold and mildew and their odours when used as directed. For use on non-food contact surfaces only.

DIRECTIONS FOR USE:

Apply ECONO-CIDE B 1002 to walls, floors and other hard (inanimate) non-porous surfaces such as tables, chairs, countertops, sinks, tile, porcelain, and bed frames with a cloth, or mop so as thoroughly wet surfaces. For heavily soiled areas, a preliminary cleaning is required. Prepare a fresh solution daily or when use solution becomes visibly dirty.

Mold and Mildew Control: at 4 mL/L ECONO-CIDE B 1002 will effectively inhibit the growth of mold and mildew and the odors caused by them when applied to hard, non-porous surfaces (as indicated above). Allow to dry on surface and repeat when mildew growth returns.

PRECAUTIONS:

KEEP OUT OF REACH OF CHILDREN.

FIRST-AID:

Probable mucosal damage may contraindicate the use of gastric lavage. Measures against circulatory shock, respiratory depression and convulsion may be needed.

DISPOSAL:

1. Triple- or pressure-rinse the empty container. Add the rinsing to the treatment site.
2. Follow provincial instructions for any required additional cleaning of the container prior to its disposal.
3. Make the empty container unsuitable for further use.
4. Dispose of the container in accordance with provincial requirements.
5. For information on the disposal of unused, unwanted product, contact the Manufacturer or the Provincial Regulatory Agency. Contact the Manufacturer and the Provincial Regulatory Agency in case of a spill, and for clean-up of spills.
